Confirmation of Minutes

The draft minutes of the meeting held on 11 December 2014 were not presented for confirmation as there were insufficient members present to do so.

Confirmation of Agenda

The agenda was confirmed without addition or alteration.

1. Authorisation to execute Affected Persons Approval (APA) form on behalf of Queenstown Lakes District Council (QLDC) relating to RM100777 (PSC 15/01A/01)

Consideration was given to a request from Skyline Enterprises Limited for an Affected Persons Approval (APA) form from the Queenstown Lakes District Council to indicate the Council's support for RM100777, which was an application for consent to undertake helicopter landings on and to make safety improvements to an existing helipad located adjacent to the Skyline Gondola building within the Ben Lomond Recreation Reserve at Bobs Peak. The report recommended that authorisation to execute the APA be given to the Senior Parks and Reserves Planner.

The Mayor commented that the Committee could grant APA and this did not need to be delegated to the Senior Parks and Reserves Planner. It was suggested that the recommendation be amended to reflect this. A recommendation b. was also added authorising the report and resolution to be made public as part of the next Mayor's report to Council. There was a question on point 5 of paragraph 12 in the report and it was clarified that scenic flights did not originate from the skyline complex but landed there as part of a flight that would have originated elsewhere.

On the motion of Mayor van Uden and Councillor MacLeod it was resolved that the Property Subcommittee:

- a. Grant Affected Party Approval on behalf of Queenstown Lakes District Council in relation to helicopter landing activities sought at Ben Lomond Recreation Reserve (resource consent application RM100777).
- b. Authorise this report and resolution to be made available to the public as part of the next Mayor's report to Council.

On the motion of Councillor MacLeod and Mayor van Uden it was resolved that the Property Subcommittee move out of public excluded.
