Lake Hawea, 15th May 2018,

We, Timothy-Dean & Carmen-Jayne, a man and woman of mind, body and soul, the peaceful, authorised representatives for the artificial persons Timothy Dean Ryan and Carmen Jayne Howell, and authorised representatives for the KeepHaweaBeautiful movement write to you to notify you of stating DECLARATION of NON CONSENT to Special Housing Areas being allocated to the area known as Hawea, Central Otago.

Attached to this letter is a true, correct, verified copy of the declaration displaying 380+ autographs direct from the people of our community and the wider area known as the Upper Clutha. The people who have autographed this declaration oppose the fast track development of Special Housing Areas in the Hawea Area, and we require that you take note of the will of our community and put a stop to any current or future Expression of Interest for Special Housing Area(s) in our area. This campaign is ongoing and we may in future have more autographs to present.

We, as a community, require that a moratorium be placed upon all future growth and development of the Hawea Area for a minimum of two years, or until we have formulated a community lead plan for our area providing a vision and strategy for sensible, smart, sustainable development to the year 2050, consented by the majority of our community, and embedded and honoured in local Council policy.

It is of great concern to us and our community that fast tracked growth be bought upon us without our input or consent. In reading the special housing area lead policy and housing accord documents, of the Queenstown Lakes District Council we note that it is **highly unethical and unlawful** that all the true and correct processes pertaining to response from effected communities has been removed, in favour of un-opposable development.

Where is the freedom to speak out against such developments? Whatever happened to participatory democracy? Legislation cannot remove the rights of people to speak to a decision that affects their well-being; this contravenes the basic human rights established by Common Law.

The process of developing a special housing area in the Hawea area of Central Otago stands to effectively double or even quadruple the size of our community in a very short space of time. The social and environmental implications of such a process cannot be taken lightly. The current district plan states that there is enough housing provision for the community through to 2033.

People in our village are deeply concerned about the harm that would come to them through this process. Harm is particularly centered in the loss of democratic processes, loss of trust in our Council and Councillors to do the work that we require of them. Harm in the form of the loss of our rural heritage, wide open spaces and highly productive rural landscapes, habitats and dry-land ecosystems. Harm to the pristine waters of Lake Hawea, underground water systems, aquifers, the Hawea River and its ecosystems. Such environmental harm is the very thing that the Ministry for the Environment is currently warning us about.

Fast tracked urbanisation would radically degrade our physical and social environment, displacing families, and disrupting our diverse local economy.

We, the community of the Hawea area are not calling to end growth, we are calling to end rapid urbanisation, ad hoc, badly planned, profit motivated, speculative and exploitive development that has zero regard to the community that it effects.

The time has come to reverse the trend towards the rapid urbanisation of our rural landscapes in favour of creating strategic, community focused and lead models for true affordability, diverse resource based economies and industry, which enhance our communities whilst upholding our rural heritage, creating meaningful lifestyles and homes for all.

Examples of such initiatives could be community social enterprise, small scale organic farms, local food production, decentralising drinking water, waste water, sewerage and waste management to community operated entities. Creating direct participatory democracy through the decentralising of council decisions and processes to better represent the unique character of each community. Those that best understand and represent a place are those that live there.

To drive rapid growth and irreversible destruction of lands for profit to experiment with the creation of affordable homes through a ratio based programme is oxymoronic and illogical. This acts as a bandaid upon the far deeper wound of dependance upon destructive and unsustainable construction practices, poorly managed and regulated real estate markets, property speculation, lax overseas investment regulation and boom bust cycles that this type of economy creates. It is time to end all special housing areas and revoke the legislation that enables the exploitation that they bring.

We need you to deny any expression of interest for special housing areas in the Hawea area on our behalf and to work with the Hawea Community to create a unique and strategic approach to economic diversity and growth of our rural community, fostering truly smart, sustainable and future focused thinking for the benefit of all.
