Closure of Streets to Ordinary Vehicular Traffic

PURSUANT TO THE LOCAL GOVERNMENT ACT 1974, notice is hereby given that consideration will be given by Queenstown Lakes District Council under delegated authority, to the closure of the following roads to ordinary vehicular traffic for the purpose of holding the **Hanley's Farm Community** Festival 2020:

Road to be Closed:

Bannister Street from Jack Hanley Drive to Ward Street, Jack Hanley Drive from Muster Road to Shepherd Road and the southern end of Shepherd Road for approximately 50 metres from the Jack Hanley

Road intersection

Period of Closure:

1000 Friday 21 February 2020 to 2100 Saturday 22 February 2020

(Note: Controlled access with be available for residents within the closure area)

It will be an offence under the above regulations for any person otherwise than under authority of an authorised permit to use the roads for ordinary vehicular traffic during the period of closure.

What is proposed:

Construction of an 89 room hotel development with ancillary hotel amenities including a function room, gymnasium, spa facilities, indoor swimming pool and bar and restaurant associated with the hotel. The proposal includes associated landscaping and basement carparking accommodating 91 car parking spaces, with a further 3 at-grade spaces to serve the presidential suite. Earthworks are required for construction and the establishment of infrastructure for the development.
