Closure of Streets to Ordinary Vehicular Traffic

PURSUANT TO THE LOCAL GOVERNMENT ACT 1974, notice is hereby given that the following road will be closed to ordinary vehicular traffic for the purpose of Installation of Cow Lane Street Art:

Road to be Closed: Cow Lane

Period of Closure: Monday 21 January 2019 to Sunday 3 February 2019 from 1500 to 2100

daily.

It will be an offence under the above regulations for any person otherwise than under authority of an authorised permit to use the roads for ordinary vehicular traffic during the period of closure.
