Adoption of Traffic and Parking Bylaw 2018

Queenstown Lakes District Council has adopted a new Traffic and Parking Bylaw 2018.

The new bylaw comes into force on **1 March 2019** and replaces the previous Traffic and Parking Bylaw 2012.

Changes to the bylaw reflect the needs of a growing community and provide greater clarity and ability to address Traffic and Parking concerns as they arise.

Proposal to Stop Legal Road

ONSLow ROAD & HERRIES LANE, QUEENSTOWN

Queenstown Lakes District Council, under Section 342(1)(a) and Schedule 10 of the Local Government Act 1974, proposes to stop a portion of ONSLOW Road and Herries Lane described as that parcel of land containing 2,001 m² being section 4 on survey office plan 524303.

The portion of road proposed to be stopped is part of package of land that was to be stopped, sold and exchanged with the Queenstown Country Club, however the land may now be retained by the Council, leased or sold, subject to a further Council resolution.
