Notice of Intention to Grant Lease over Recreation Reserve

FRANKTON CAMPGROUND

PURSUANT TO SECTIONS 54(1) and 61(2) OF THE RESERVES ACT 1977

The land described in Schedule A of this Notice (the Land) is vested in the Queenstown Lakes District Council pursuant to Section 26 of the Reserves Act 1977 as Recreation Reserve and Local Purpose Reserve. Queenstown Lakes District Council is considering granting a new lease over the land for a Camping Ground pursuant to Section 54(1) and 61(2) of the Reserves Act 1977.

Pursuant to Sections 54(1), 61(2) and 119 of the Reserves Act 1977 the Council has an obligation to publicly notify its intention to grant such lease by way of this Notice.

- b) Local Purpose (Recreation) Reserve measuring 183 square metres being Lot 2 DP 22500 contained in Certificate of Title OT15D/598 (Otago Registry).
