## Closure of Streets to Ordinary Vehicular Traffic

**PURSUANT TO THE LOCAL GOVERNMENT ACT 1974**, notice is hereby given that the following roads will be closed to ordinary vehicular traffic for the purpose of holding the **LUMA Light Festival 2019**:

**Roads to be Closed:** Rees Street from Beach Street to Marine Parade  
Marine Parade from Rees Street to the Memorial Gates

**Period of Closure:** Friday 31 May 2019 from 1500 to 2200  
Saturday 1 June 2019 from 1600 to 2200  
Sunday 2 June 2019 from 1600 to 2200
