Queenstown Airport Corporation: Vacancy for Director

Queenstown Airport Corporation Ltd (QAC) is owner and operator of Queenstown International Airport and the operator of Wānaka Airport. Queenstown Airport is the fourth largest and fastest growing airport in Aotearoa New Zealand. One of the present directors is retiring from the Board at the Annual General Meeting in October and the shareholders are seeking to appoint a replacement.

QAC is a Council Controlled Trading Organisation (CCTO). It is owned by the Queenstown Lakes District Council (QLDC – 75.01%) and Auckland International Airport (AIAL – 24.99%). This ownership structure creates an additional layer of public accountability and responsibility for the Board.
