### Invercargill Airport Ltd: Vacancy for Independent Director

Invercargill Airport Ltd (IAL) is a subsidiary company of Invercargill City Holdings (Holdco) which is a holding company 100% owned by the Invercargill City Council. IAL provides all airport related services for Invercargill and is the gateway to the city and the wider Southland region, hosting over 307,000 passengers in 2018. IAL is 97.2% owned by Holdco and 2.8% by four local Rūnaka.

Invercargill City Council and IAL, along with the Queenstown Airport Corporation and its major shareholder Queenstown Lakes District Council, see value in strengthening the connection between the airport companies with the objective of increasing economic activity for the city and wider region.

This new role is being established specifically as one of a number of initiatives to assist in building that connection.
