Subject: Annual Plan Submission

I would like to make a submission for consideration for the draft Annual Plan for 2017/2018. I am writing this submission on behalf of the Queenstown Squash Club. I know submissions closed on Friday, but we only found out about the process on Thursday and I have been out of town on work until last night.

We have a goal to supply quality squash facilities to the wider Wakatipu community and international visitors that are consistent with the high standard of venues on offer throughout the region.

Our current facilities are incapable of catering for Queenstown's current massive growth rate. Whilst the central location makes the venue easily accessible to visitors, it leaves little or no room for expansion. For locals the three carparks that are assigned to the club are not conducive to club events and other parking in the area is limited. We currently have two courts (one of which can only be accessed from outside the building). This is less than Cromwell, Wanaka and Alexandra, all of whom cater to far smaller populations, but have larger membership numbers. The spectator area is only capable of comfortably seating around 15 people which makes hosting tournaments and events to bring players in from outside the area very challenging. There are no kitchen/bar facilities to assist in hosting such events, and help bring valuable revenue into the club.

Our membership is fast growing beyond what our current aging facilities can offer. Whilst we need the membership growth to update and improve the facilities, we cannot accommodate many more members without increased facilities. This year alone we have had at least one new member join every week and the 2017 squash season does not traditionally start till May.

We are currently also focusing on getting school aged kids involved in the sport. Offering the courts and the time of senior members to school groups in order to nurture the sport for future generations and give our youth another option to keep them active.

We are also in the process of installing an online booking system, that will make booking courts easier and more streamlined for both members and visitors.

Squash is a great sport for bringing together the local community and also the wider community. It has always had a strong following in the Central Otago area, and is currently experiencing renewed growth.

We believe there is a huge potential for growth in the sport in Queenstown however we are currently being held back by the size and quality of our facilities.

In the past there have been plans to build new courts and move the club to the Queenstown Events Centre in Frankton. However these plans have been shelved on more than one occasion. The club was also awarded a grant to go towards building a better venue for the sport in Queenstown however due to lack of options this grant has now expired – unused.

We wish for the club's premises be considered in the council's future planning for the region and potentially part of the Queenstown Town Centre Masterplan. We would also like to request feasibility funding to enable a business case / feasibility study to investigate whether upgrading the courts, adding facilities etc or building new courts, either Downtown, in Frankton, or elsewhere, is the better option.

## Upper Clutha Tracks Trust Submission - Annual Plan 17/18

Attention: Queenstown Lakes District Council

#### Introduction

Upper Clutha Tracks Trust (UCTT) would like to support any work that Council is or will undertake to progress a safe and efficient on and off-road network for cycling and walking. There are a number of strategies that have proposed actions to work towards this end. Many of the initiatives have not been completed. UCTT would like to work with Council to ensure this network continues to be developed and is fit-for-purpose.

#### Background

The objectives of the Trust are:

'To promote, support, fund and advocate the establishment of:

- (a) a functional and interconnected network of tracks...
- (b) the roading network for commuter and recreational road cycling.
- 11.1 The functions, powers and duties of the Trustees shall be:
- (d) To develop and maintain a relationship with the QLDC, the Department of Conservation, Otago Conservancy and any land owner such that those bodies are aware of the opportunities for walkways and to integrate those needs within their own management and development of their assets and services.'

Since the Trust was formed in October 2006 it has undertaken a range of projects in partnership with the groups mentioned above and new groups such as Bike Wanaka. We have also supported a number of initiatives such as the Aspiring Tracks Network to create a common voice for the Upper Clutha Track Network. Our current projects include:

- Red Bridge Luggate
- Dublin Bay Track
- Lower Cardrona Track
- Accessibility Project
- Devon Dairies/Newcastle Link to Hawea Flat
- Horseshoe Bend Track
- Newcastle Road track to Lower Hawea village: engineer to look at route near village, site visit to be arranged.

Thank you for the \$25k and support provided by QLDC. We also acknowledge the invaluable support from Diana Manson from the Property and Infrastructure Team, and to Rachel Brown as the liaison with the Wanaka Community Board. This helps to ensure the connections continue to be made. Thank you.

## Walking and Cycling Strategy

The Upper Clutha Tracks Trust have two aims of this submission. To:

1. Show our interest and enthusiasm to work with the Queenstown Lakes District Council and Wanaka Community Board in order to continue to implement the *Upper Clutha Walking and Cycling Strategy* and *Upper Clutha Tracks Network Strategy 2015-25*; and

2. Encourage Council to review and update these strategies, then integrate them into a Wanaka Transport Strategy.

In 2006 the Upper Clutha Tracks Trust took the lead in creating the Upper Clutha Walking and Cycling Strategy<sup>1</sup> which included an implementation plan (see attached) highlighting the infrastructure changes needed to create a safe and usable cycling and walking network. Some of this work has since been picked up and reviewed in the Upper Clutha Tracks Network Strategy by Aspiring Tracks Network. The vision for both these strategies is:

'the Upper Clutha's tracks network reflects the needs of a connected and active local and visitor community and provides a viable alternative to vehicle transport. The tracks network provides recreation and economic opportunities for all in our stunning environment'.

The research carried out by Bike'vember provided insight into where the members of the Upper Clutha thought the walking and cycling network was not living up to expectations. We would like to refer you back to that submission to list the projects yet to be achieved.

The Upper Clutha Tracks Trust propose that we work with Council in developing a strategy that works for the whole of the track network. UCTT could work on the off-road, whilst QLDC focus more on the on-road and then collaborate to ensure the network has the appropriate signage and mapping (along with Lake Wanaka Tourism and Bike Wanaka).

We look forward to continuing to work with the Queenstown Lakes District Council on developing the Wanaka Transport Strategy with particular interest in the walking and cycling network.
