I use this area A LOT to pick up or drop off my children as there is literally very few other places to do so without causing problem - there is quick access through here to then get out of town by continuing straight on. If you block this then you force me to a very long route around town, which is often heavily congested by tourists and to which has literally nowhere else to safely pull in for quick drop off/pick up. Beach St is a side a street out of the main flow and has always made for a safe, easy and quick drop and pick up if you remove this, then you make it extremely difficult to do the same anywhere else without as I say, without blocking flow of traffic, resorting to using bus pull ins or taxi stands as the only other alternative or a dangerous double parking situation. Flipping this around, there is easy pedestrian access now with little hindrance ... there is already non pedestrian 'mall' areas ... if the retailers want to be somewhere like this, then move to those retail areas. Frankly, if you make it difficult to have a safe and easy drop off and pick up area - then we'll simply stop coming into town at all in lieu of using the new areas opening up around Frankton that has easy and safe vehicular access! It would be nice if the Council could stop bowing to demands of the retailers and businesses in town and for once think about the LOCAL customers (not tourists who are on foot) and consider our needs for efficient access and parking. As locals, we have places to be and times to keep ... we are not on holiday to be able to park miles away and walk everywhere ... so please consider our requirements before taking away further car parks and making traffic flow so much more difficult!

Reasons for Preference:

Bidvest Foodservice employs 85 staff and operates food deliveries to restaurants, cafes and hotels in the wider Queenstown area. On upper Beach street alone we service 11 food businesses with an additional 11 accounts in lower Beach Street (includes Steamer Wharf) Because of the nature of high rents food operators look to maximise their use of space by providing as much customer seating/tables as possible and look to minimise storage space to drive profitability and survive in what is a tough industry. On that basis we see our town customers ordering / getting deliveries up to 4 times a day to compensate for minimal storage space in their business. This is the service expectation they have and applies to other foodservice operators as well. We operate a modern fleet of 17 temperature controlled delivery trucks of which 5 are SPECIFICALLY built to ensure they comply with the bylaw covering vehicle size in the CBD during the day. These 5 trucks whilst compliant are NOT the most efficient way to operate as their size restricts our capacity and requires us to use more vehicles and staff at a greater cost to our business (whilst adding to the congestion). The same cannot be said of other operators using larger vehicles after 10am. As a business we support option #4 (B) on the basis that ALL current loading zones are RETAINED to ensure efficient service to our customers and maximise productivity to our business and others. We also suggest that current car parking in upper Beach Street be redesignated to loading zone status to allow speedier deliveries of all good service vehicles and thereby reducing congestion and illegal parking. Access from Cow lane is restrictive and any backup of illegal parked vehicls means it stops the flow. It is stated in the overview and our understanding that consideration is being given to relocating parking spaces lost to where current loading zones are located. With a high concentration of businesses (food and others) clustered around a confined space (which is our CBD) they are all in need of inwards goods deliveries which be it ourselves, couriers or other freight companies currently struggle to manage due to the limited number of loading zones. What loading zones that are allocated are filled more often than not with tradesmans vehicles, busses, taxi's, rental cars and Joe Public who nip into shops/banks/cafes which leads to congestion, frustration and illegal practices. The expectation now that you should be able to park in the centre of town in unrealistic. We need to be looking at providing park and ride or parking on the peripheral of town. Alternatively we have Man St carpark which is under utilised. As the town grows we need to accomodate more loading zone spacing rather than creating more carparks at theri expense. The loss of the carparks outside Fergburger has a commercial impact on our business in that it now takes longer to deliver therefore

increases our operating costs. Bidvest Queenstown strongly opposes any consideration to reduce loading zones within the CBD area and strongly supports the creation of additional Loading Zones. We also have concerns with the impending development of Upper Beach Street with the demolition and rebuild of 3 tenancies by Trojan holdings that during this period any loading zones will be occupied for long durations by trades vehicles associated with this development. During the recent rebuild outside the old Outside sports building in Shotover Street trades vehicles occupied the loading zones for durations of up to 6 hours a day meaning goods service vehicles could not use them or had to park illegally. We urge the council to use foresight, boldness and courage to futureproof the town (and it's surrounds) for continued growth in the goods services sector

The completion of this should ideally coincide with the completion of the Vudu site reconstruction, with work undertaken in either May/June or Sept/October to minimise construction disruption and dust. Suggested scope of work to include: -The removal of the existing 60+ bollards that attempt to create a "fence" to shield pedestrians from vehicles, open up the space -Changes to the kerb/channel and paving at the top of Beach Street (potential Loading Zone space?) with automated retractable bollards installed to prevent vehicle access after any service delivery times. The bollards to be controllable by emergency services for access. -The paving, seating, contour, bollards and streetscape of Upper Beach Street to be upgraded to match with the dark grey style of the refurbished adjacent

The qldc might need to look a trade and services delivery times as one must ask with the amount of both local and visitor traffic (both vehicle and pedestrian) if it might be time to have the trades and services restricted to delivery maintenance between midnight and 8am...

Reasons for Preference:

I think it is great that Council are considering the options as listed, but my preferred option is none of the above. I think Council could be looking more holistically at pedestrian opportunity in Queenstown and proposing a much bolder strategy for the Town. One concept could be to create a new zone bordered by Shotover, Stanley & Sydney Streets through to the waterfront as 'Pedestrian Priority' or shared space. This is where all bollards, traffic markings and delineations are removed so that vehicles can access these streets at a slow speed. There would be signage at the start of the zone denoting pedestrian priority and all areas paved as a single surface. Existing pedestrian only streets would remain, such as Mall Street. This allows the greatest flexibility for traffic movement (emergency vehicles / loading etc.) and enables a positive interaction between pedestrians and motorists. I believe a traditional separation as is proposed (with bollards or by totally excluding traffic) gives motorists a cue that they can drive faster on the delineated roading areas. It will also over time increase the loading on Shotover Street. For Beech Street - as a trial I would suggest council removes all traffic bollards and road markings and erect pedestrian priority signage at the beginning of the street. Loading and parking will need to be considered in marked zones if required. Pedestrians will then feel that the entire paved surface is their domain (much like a town square), rather than the space behind the bollards as exists. Vehicles will then be more aware of pedestrian movement and will slow down or choose other routes. The street will at some stage require a landscape upgrade as the paving and furniture is becoming dated, but this could occur at a later date. I am happy to assist with this process and any other design consultation that may be required, having led the design on several shared space upgrades in the Auckland CBD. Richard Tyler NZILA reg. My business for example, operates from a tiny kiosk. Due to lack of space we require deliveries hourly (in peak season) of freshly baked goods direct to our kiosk. I realise that all businesses have different needs, but given how busy Shotover Street can be in peak seasons, I think dispensations should be made to those who are trying to service their businesses, and keep customers happy. My husband and I visited a small town in the Italian Alps 3 years ago - Courmayeur, which has similar issues to what we now face. They have bollards with sensors that rise and fall automatically when a vehicle approaches that has a special fob. I understand that this costs money, but it is possible to manage the flow of vehicles in this way, and Europe has proven that it works by only allowing 'authorised' vehicles access. This is my suggestion and although unfortunately I cannot make the hearing I would very much like my submission to be taken into consideration. Access to these streets will now only be from Shotover Street which will potentially mean a loss of access and business to these streets. All these issues need to be taken into consideration when looking at this trial closure.
