

To Whom It May Concern,

It is a pleasure to provide comment in favour of the establishment of a retirement care facility for the older aged community of the Wakatipu Basin. As a Specialist Palliative Care Nurse working primarily within the region, I have a particular interest in the welfare of our older population. My current position, which I commenced in July 2015, was created by Hospice Southland in response to the community's strong desire to enable palliative patients to be cared for in the Wakatipu. With its rapidly increasing and aging population, there is a growing need for more accessible and timely palliative care.

I am aware that New Zealand's projected statistics depict that the total number of deaths within New Zealand will increase from approximately 30,000 to 55,500 each year by 2068. The average age will also increase, with more people living beyond 85 years of age. The establishment of new and innovative accommodation facilities that will mitigate the challenges faced caring for an aging population with more complex health needs such as dementia, is recognised as requiring vigilant attention and planning.

Addressing the disparities that exist for rural communities within the Southland region is a focus within the Southern District Strategic Plan. However despite this, I am mindful that for many aging Wakatipu community members, the availability of the level of care that they require is currently not accessible, or is limited within the region. For example, presently there are no dementia level care facilities and the number of hospital level beds in the Wakatipu does not meet present-day demand. It is both heart breaking and frustrating to be informed all too frequently, that our Wakatipu aging members must leave their familiar surroundings and environment in order to receive the level of care that they require.

It was therefore, uplifting to see an ad in the Otago paper recently regarding a retirement facility to be built in the Wakatipu offering all levels of care, including hospital and dementia. Such a facility will not only allow the aged members of the Wakatipu to stay in their own surroundings, but it will also improve their quality of care and quality of life.

I wish Fraser and his team all the best with their new endeavour and I look forward to working with this team in the future.
